s we look forward to our A90th anniversary coming up in 2010, we will strive to find innovative ways to meet the needs of children and families during the next 90 years. We will do that by continuing to call for a White House Conference on Children and Youth and promoting policies that help children thrive. We will also continue to give our members and the communities they serve the tools they need to implement the Fostering Connections to Success and Increasing Adoptions Act.

We spent time during 2007 and 2008 reviewing our operations and preparing for a new era of leading the child welfare field. We took a fresh look at our mission statement and examined our strategic focus to identify creative, effective, and efficient approaches that will carry CWLA and its members into the future.

We kept our presence strong on Capitol Hill, working from our national policy framework to advance some of the most significant changes in child welfare policy in the last decade perhaps even since the passage of the Adoption Assistance and Child Welfare Act of 1980. As a result, children in foster care will have a better chance of finding permanent families through kinship guardianship and adoption, and they will have greater supports in their transition from foster care to young adulthood. We also worked toward the important goals of educational stability and improved health care coordination for children in foster care.

In coming years, we will create new strategic partnerships that will bring to our members and the field some of the highly specialized and innovative work being done by our colleagues around the country. We have begun work to evaluate potential relationships, and we anticipate bringing several partnerships to fruition in the years ahead.

Moving forward, we will continue to highlight advances in public-private partnerships that show improved outcomes for children and families. Better outcomes is the framework from which we will continue to guide leadership retreats and regional trainings, publish resources to assist child welfare workers in their daily work, and advocate in Congress for better policies for our children.

# Strategic Plan O th anniversary in 2010

#### Vision

Our vision is that every child will grow up in a safe, loving, and stable family.

#### **Guiding Beliefs**

The goals of CWLA's services are directed first and foremost to the best interests of children, youth, and their families. Our leadership focuses on policy and practice in general and as related to advancing equity in representation and outcomes for children of color and populations of diverse cultures and languages. Therefore, we believe:

- Every child, youth, and family is unique and has an intrinsic value to society.
- Every child and youth should be nurtured, be safe, have permanency, have a family that provides for his or her well-being, and have the chance to develop to his or her full human potential and contribute to the common good.
- All families deserve to be valued, respected, and supported to successfully care for their children through healing, preservation services, or the opportunity for safe reunification.
- Children and youth thrive, or fail to thrive, in the context of families, kinship systems, and communities. Our practice must recognize and value these connections.
- The family and the child welfare system both have specific responsibilities; as well, the society

- at large shares the responsibility for promoting healthy human growth and development.
- A strong child welfare system is holistic; integrated within and across other child, youth, and family serving systems; and sensitive to race, culture, ethnicity, gender, sexual orientation, disability, and family composition.
- Active partnership with children, youth, and families who are consumers of service is critical to the success of CWLA and the child welfare system.
- CWLA comprises organizations and individuals that have come together because we share
  a common mission and value interdependence. We acknowledge the power, leverage,
  and legitimacy that our national membership
  network provides. We know that we are
  stronger together than alone.
- CWLA is a learning organization bound by the shared values of openness, trust, accountability, and a commitment to continuous quality improvement.
- CWLA's highest priority is to identify linkages between systemic actions and outcomes for children and youth and their families.

#### **Desired Outcome**

A child welfare system that is accessible, developmentally and culturally responsive, and ensures safety, permanence, and well-being for children, youth, and their families.

#### Mission

CWLA will lead the nation in building public will to ensure safety, permanence, and well-being of children, youth, and their families by advancing public policy, defining and promoting practice excellence, and delivering superior membership services.

#### **Focus**

Our focus is on the children and youth who may have experienced abuse, neglect, family disruption, or a range of other factors that jeopardize their safety, permanence, or well-being. CWLA also focuses on the families, caregivers, and communities that care for and support these children.

#### **Goals and Strategic Priorities**

- 1. Shape public opinion and promote public policies at every level.
  - Develop a national policy agenda and advise and support state, tribal, and local legislative policy agendas.
  - Create a mechanism to respond to and proactively increase bipartisan political support for national, state, tribal, and local laws, policies, and resources.
  - Take the lead in developing a comprehensive national call to action for an education and awareness campaign with the active engagement of members, youth, and families.
- 2. Promote excellence in practice.
  - Develop, revise, and advance CWLA's research-based and aspirational *Standards* of *Excellence* for the child welfare system through the active engagement of members, youth, families, and other professionals.
  - Develop consultation tools, professional training, and technical assistance responsive to the field's needs and support the implementation of practices and programs reflecting the *Standards of Excellence*.
- 3. Ensure the open exchange of ideas, resources, knowledge, and data.

- Provide forums to facilitate this exchange within and across systems.
- Develop the capacity to better use existing data, provide access to new data, and examine data trends to bring solutions to new and emerging issues.
- Influence the type of child welfare research performed as part of a national research agenda and promote better outcome-based and research-based decisionmaking overall.
- 4. Capitalize on the strength and diversity of our members representing both the public and private sectors.
  - Promote the highest level of engagement of CWLA's private and public member agencies, their boards, and affiliated stakeholders in national, state, tribal, and local discussions and actions that align policy, research, practice, and professional development.
  - Build and strengthen public and private agency partnerships.
  - Initiate and sustain nationwide focus on the needs of children, youth, and families by insisting on individual and organizational accountability.
- 5. Strengthen the capacity of CWLA and its member agencies.
  - Build greater internal capacity to support CWLA's role in child welfare that aligns policy, research, practice, and professional development.
  - Craft a resource development plan to increase CWLA's financial resources and assist members with fund development.
  - Develop and implement strategies to ensure critical knowledge and expertise within CWLA, and to attract and retain child welfare leaders throughout the service delivery system.
  - Leverage knowledge and experience within CWLA and form partnerships with other organizations to expand and enhance our services to members.

# Founding Member Spotlight Children's Friend - Rhode Island

Children's Friend is celebrating 175 years of service to Rhode Island's children and families. Harriet Ware envisioned the organization in 1834, and it was formally founded in 1836 as Providence Children's Friend Society. Using the charity of local churches, Ware used the organization to make several important reforms to the lives of Rhode Island children. With a focus of providing proactive, relevant, and comprehensive services that respect, support, and strengthen Rhode Island families, the organization helps some of the state's most at-risk children.

Over the years Children's Friend has made a great impact on

the history of child welfare in America, including demanding a child's right to education, and the passage of several child protection laws. Many Children's Friend staff members were influential in the creation of the Rhode Island Society for the Prevention of Cruelty to Children in 1882. As a leader in children's rights, Children's Friend was instrumental in the fight to pass child labor laws, especially helping to set the minimum work age at 15 years old in 1923.

Today, Children's Friend offers a number of services to the state's families, including birth parent and family counseling, a nutrition program for children and adults, daily child care, involved father initiatives, and help with adoption and foster care. In 2008 alone, the organization's services helped almost 18,000 children, families, and child care professionals.

# Founding Member Spotlight Children's Home Society of New Jersey

The Children's Home Society (CHS) of New Jersey has been serving children and families since 1894. Reverend Martin Van Arsdale originally founded the first CHS in Chicago in the 1892. He was moved seeing a mother leaving a poorhouse with a small child and sought a way to find better placement homes for children instead of living in almshouses with adults. With 26 junior reverends, he brought this idea to 26 states. In 1894, Van Arsdale sent Reverend Martin T. Lamb to start the Children's Home Society of New Jersey. Lamb and his staff worked hard to give children in three states—



New Jersey, Eastern Pennsylvania, and Delaware—an appropriate environment to grow up in, finding foster homes in 1894 for every child he temporarily protected in the orphanage.

Today, CHS still focuses on every child's right to a healthy, loving family. Through its mission, "saving children's lives and building healthy families," CHS serves children and at-risk families from New Jersey and Eastern Pennsylvania with services ranging from permanency and clinical and mental health to community family center-based programs, early childhood, and early childhood parenting education. CHS offers birth parent counseling, counseling for traumatized children and their families, foster care, postadoption counseling, training for child care providers, domestic and international adoption, neighborhood Family Success Parent/Child Centers and a school-based program for middle school youth. After rigorous evaluation, the school-based program, Kids Intervention with Kids in School, was nationally recognized by SAMHSA as a youth primary prevention program, giving it promising best practice status. Each year, CHS helps more than 36,000 infants, children, youth, and families, including grandparents.


Donna Pressma, CHS's current president and CEO, chaired CWLA's Task Force on Children, Youth, and Families with HIV Infection, which examined policy and established CWLA guidelines for those working with children and families living with HIV. She testified with Senator Metzenbaum and then-Surgeon General Koop on behalf of CWLA to help establish the Ryan White Act, which now funds many of the HIV services across the country. Pressma has also participated in other CWLA task forces, including child care.

## Founding Member Spotlight Children's Aid Society - Alabama

For 97 years, the Children's Aid Society in Homewood, Alabama, has kept in line with its mission that all children have a right to a secure household and a nurturing environment. It began when a group of concerned citizens in Birmingham held a meeting and concluded that a formal agency should be created to care for neglected children. Starting off with managing a juvenile detention center and a couple of orphanages, CAS has slowly developed to accommodate adoption services and training programs. CAS has grown into a much larger network of charitable groups and agencies aimed at providing assistance to families lacking in resources to support their children, and seeking to find other alternatives for children without adequate care.

The Children's Aid Society offers a wide variety of services, ranging from Prevention Services, Alliance Services, Family Preservation Services, to Permanency Planning and Support Services. These were all tailored to help build and reestablish households that are conducive to the healthy growth of a child. Among many others, CAS programs include training sessions that help teenagers resist drugs and peer pressure, sessions for adoptive and foster families to smooth the transitional periods, and programs that reunified families with their children by supplying them with the knowledge and skills to be able to stay together. More than 800 families, tens of thousands of individuals, were helped by CAS in 2007 alone.

As a founding member of CWLA, CAS and CWLA have worked together to better the lives of children throughout the country. In 2005, after Hurricane Katrina left an insurmountable number of children orphaned and homeless, CAS offered support services and counseling to families. In 2007, CWLA staff visited CAS in Alabama to witness disaster relief efforts and the hurricane's impact on child welfare.
