# ARIZONA'S CHILDREN 2015

## Arizona's Children At a Glance<sup>1</sup>

#### CHILD ABUSE AND NEGLECT

- In 2013, Arizona had 63,286 total referrals for child abuse and neglect. Of those, 42,547 reports were referred for investigation.
- In 2013, 13,171 children were victims of abuse or neglect in Arizona, a rate of 8.1 per 1,000 children, representing a 23.8% increase from 2012. Of these children, 97.9% were neglected, 10.5% were physically abused, and 3.5% were sexually abused.
- The number of child victims has increased 246.3% in comparison to the number of victims in 2009. 10
- In 2013, 54 children in Arizona died as a result of abuse or neglect. 11
- In 2013, 14,399 children in Arizona lived apart from their families in out-of-home care, compared with 9,423 children in 2009. In 2012, 6,072 of the children living apart from their families were age 5 or younger, and 1,570 were 16 or older. <sup>12</sup>
- The number of children living apart from their families in out-of-home care has increased 52.8% in comparison to the number of children in out-of-home care in 2009. 13
- Of Arizona children in out-of-home care in 2013, 40.6% were white, 9.0% black, 42.3% Hispanic, 1.8% American Indian/Alaskan Native, 0.2% Asian or Pacific Islander and 4.2% of more than one race or ethnicity.

## ADOPTION, KINSHIP CARE, AND PERMANENT FAMILIES FOR CHILDREN

- Of the 7,806 children exiting out-of-home care in Arizona in 2012, 49% were reunited with their parents or other family members.<sup>15</sup>
- In 2013, 2,522 children were legally adopted through the public child welfare agency in Arizona, a 10.9% increase from 2.275 in 2012.<sup>16</sup>
- Of the 14,399 children in out-of-home care in 2013, 3,579 or 24.9% were waiting to be adopted.
- In 2013, approximately 67,754 Arizona grandparents had primary responsibility caring for their grandchildren. <sup>18</sup>
- Of the children in out-of-home care in 2012, 5,307 were living with relatives while in care. 19

#### CHILD POVERTY AND INCOME SUPPORT

- The total number of individuals receiving Temporary Assistance for Needy Families (TANF) in Arizona decreased from 37,059 in 2013 to 29,450 in 2014, a decrease of 20.5%. The number of families receiving TANF in 2014 was 13,168, a 19.1% decrease from 2013.<sup>20</sup>
- From 2012-2013, for every 100 Arizona families living in poverty, only 9 received TANF benefits.<sup>21</sup>
- In 2013, \$359,429,741 was spent in Arizona on TANF assistance, including -6% on basic assistance, 0% on child care, 0% on transportation, and 106% on nonassistance. 22
- In 2013, \$83,378,296 was spent on WIC (the Special Supplement Nutrition Program for Women, Infants, and Children) in Arizona, serving 157,667 participants. <sup>23</sup>



- In 2013, Arizona distributed \$322,560,931 in child support funds, a 0.2% decrease from 2012.<sup>24</sup>
- In 2013 in Arizona, 573,000 children lived in households with a high housing burden, where more than 30% of monthly income is spent on housing costs. <sup>25</sup>

#### CHILD CARE AND HEAD START

- In 2013, Arizona had a monthly average of 22,800 children served by subsidized child care; 27,500 children received subsidized child care in 2012 and 26,000 in 2011.<sup>26</sup>
- In 2014, to be eligible for subsidized child care in Arizona, a family of three could make no more than \$32,244, which is equivalent to 60% of the state's median income.<sup>27</sup>
- As of early 2014, Arizona had 6,366 children on its waiting list for child care assistance.<sup>28</sup>
- In 2013, Head Start served 13,266 Arizona children, a 6.2% decrease from 2012.<sup>29</sup>

#### HEALTH AND SUBSTANCE ABUSE

- In 2014, 619,100 children younger than 19 were enrolled in Medicaid in Arizona—63% of the total number of enrollees in the state.<sup>30</sup>
- In 2012, Arizona had 35,679 children enrolled in its State Children's Health Insurance Program, a 78.0% increase from 2011, when 20,043 children were enrolled.<sup>31</sup>
- In 2013, Arizona had 191,760 uninsured children. 32
- In 2012, 5,997 babies were born weighing less than 2,500 grams in Arizona.<sup>33</sup>
- In 2011, 507 infants under age 1 died in Arizona.<sup>34</sup>
- In 2012, the birth rate for teens 15–17 in Arizona was 19 births per 1,000 girls; for teens 18–19, the rate was 66. This reflects a total rate of 37 births per 1,000 girls ages 15–19.<sup>35</sup>
- Cumulative through 2013, 13,538 adults and adolescents, as well as 47 children younger than 13, were reported as having HIV/AIDS in Arizona.<sup>36</sup>
- In 2013, an estimated 34,000 children ages 12–17 and 386,000 adults age 18 and older were dependent on or abusing illicit drugs or alcohol in Arizona. <sup>37</sup>

## **VULNERABLE YOUTH**

- In 2011, 783 children aged out of out-of-home care—exited foster care to emancipation—in Arizona. 38
- In 2013, 36,000 Arizona teens ages 16–19 were not enrolled in school and were not working.
- In 2013, 131,000 young adults ages 18–24 were not enrolled in school, were not working, and had no degree beyond high school.<sup>40</sup>
- In 2013, approximately 24,000 children ages 12–17 in Arizona needed but had not received treatment for illicit drug use in the past year. 41
- In 2013, approximately 17,000 children ages 12–17 needed but had not received treatment for alcohol use in the past year.
- In 2013, 44 Arizona children younger than 20 committed suicide, a rate of 2.45 per 100,000 children.

### JUVENILE JUSTICE AND DELINQUENCY PREVENTION

- In 2013, 53 children under age 19 were killed by a firearm in Arizona, a 14.5% decrease from 62 in 2012.
- In 2013, 29,861 children younger than 18 were arrested in Arizona, a 8% decrease from 32,428 arrests in 2012. Of the



arrests in 2013, 955 were for violent crimes. 45

In 2013, 936 children lived in juvenile correction facilities in Arizona.

## CHILD WELFARE WORKFORCE<sup>47</sup>

- A 2003 General Accounting Office (GAO) report documented that staff shortages, high caseloads, high worker turnover
  and low salaries impinge on delivering services to achieve safety, permanence, and well being for children. In Children's
  Rights 2009, A Long Road Home report, similar challenges to the child welfare caseworkers were identified, in addition
  to no standard training or consistent background requirements, need for meaningful supervision, and lack of private
  workspace, technology and other resources.<sup>48</sup>
- The federal Child and Family Service Reviews have clearly demonstrated that the more time a caseworker spends with a child and family, the better the outcomes for those children and families. 49
- According to the 2003 GAO report, the average caseload for child welfare/foster care caseworkers is 24–31 children; these high caseloads contribute to high worker turnover and insufficient services being provided to children and families. CWLA recommends that foster care caseworkers have caseloads of 12–15 children.
- The National Association of Social Workers 2012 Document to the Obama Administration called for full funding of the Child Abuse Prevention and Treatment Act (CAPTA) and Promoting Safe and Stable Families (PSSF), protection of the Social Security Block Grant (SSBG) from budget cuts and elimination, a variety of child maltreatment prevention services to be available through programs serving children and families (e.g., TANF, Head Start, etc.), maximization of collaboration amongst different systems (e.g., Child Welfare, Public Health, Juvenile Justice, etc.) to improve integration, culturally and linguistically appropriate delivery of services, identification and implementation of evidence-based practices, and incentivization of BSW and MSW students to join the child welfare workforce.<sup>51</sup>

#### FUNDING CHILD WELFARE SERVICES FOR ARIZONA'S CHILDREN

- In 2012, Arizona spent \$533,341,049 for child welfare services. Child welfare services are all direct and administrative services the state agency provides to children and families. Of this amount, \$357,596,249 was from federal funds, \$175,744,800 from state funds, and \$0 from local funds.<sup>52</sup>
- In 2012, of the \$357,596,249 in federal funds received for child welfare, 49.3% was from Title IV-E Foster Care and Adoption Assistance, 4.2% came from Title IV-B Child Welfare Services and Promoting Safe and Stable Families, 0.0% was from Medicaid, 11.7% came from Social Services Block Grant, 34.4% was from TANF, and 0.5% came from other federal sources.<sup>53</sup>
- Arizona received \$86,135,033 in federal funds for IV-E foster care expenditures in 2012, including \$42,136,623 for maintenance payments and \$43,998,410 for administration, child placement, the statewide automated child welfare information system, and training.<sup>54</sup>

To address this, CWLA is calling for Congress to authorize the National Academy of Sciences (NAS) to conduct an updated study on the child welfare workforce. It would make recommendations regarding caseloads and workloads, education levels, and training requirements. In addition, the study would examine data reporting and collection and make recommendations on how states might improve these efforts.
