# CHILD ABUSE AND NEGLECT

- In 2013, Wisconsin had 68,247 total referrals for child abuse and neglect. Of those, 25,286 reports were referred for investigation.<sup>8</sup>
- In 2013, 4,526 children were victims of abuse or neglect in Wisconsin, a rate of 3.5 per 1,000 children, representing a 2.6% decrease from 2012. Of these children, 63.7% were neglected, 20.0% were physically abused, and 23.0% were sexually abused.<sup>9</sup>
- The number of child victims has decreased 2.8% in comparison to the number of victims in 2009.<sup>10</sup>
- Wisconsin responds to lower risk, higher safety reports through alternative response services to address family issues. 3,911 reports were responded to in this way in 2013.<sup>11</sup>
- In 2013, 21 children in Wisconsin died as a result of abuse or neglect.<sup>12</sup>
- In 2013, 6,539 children in Wisconsin lived apart from their families in out-of-home care, compared with 6,796 children in 2009. In 2012, 2,393 of the children living apart from their families were age 5 or younger, and 1,035 were 16 or older.<sup>13</sup>
- The number of children living apart from their families in out-of-home care has decreased 3.8% in comparison to the number of children in out-of-home care in 2009.<sup>14</sup>
- Of Wisconsin children in out-of-home care in 2013, 46.6% were white, 31.4% black, 10.3% Hispanic, 3.8% American Indian/Alaskan Native, 0.1% Asian or Pacific Islander and 6.5% of more than one race or ethnicity.<sup>15</sup>

#### ADOPTION, KINSHIP CARE, AND PERMANENT FAMILIES FOR CHILDREN

- Of the 4,403 children exiting out-of-home care in Wisconsin in 2012, 58% were reunited with their parents or other family members.<sup>16</sup>
- In 2013, 800 children were legally adopted through the public child welfare agency in Wisconsin, a 5.1% increase from 761 in 2012.<sup>17</sup>
- Of the 6,539 children in out-of-home care in 2013, 1,153 or 17.6% were waiting to be adopted.<sup>18</sup>
- In 2013, approximately 28,771 Wisconsin grandparents had primary responsibility caring for their grandchildren.<sup>19</sup>
- Of the children in out-of-home care in 2012, 2,005 were living with relatives while in care.<sup>20</sup>

#### **CHILD POVERTY AND INCOME SUPPORT**

- The total number of individuals receiving Temporary Assistance for Needy Families (TANF) in Wisconsin increased from 64,080 in 2013 to 56,546 in 2014, an increase of 11.8%. The number of families receiving TANF in 2014 was 26,162, a 10.9% increase from 2013.<sup>21</sup>
- From 2012-2013, for every 100 Wisconsin families living in poverty, only 24 received TANF benefits.<sup>22</sup>
- In 2013, \$525,701,892 was spent in Wisconsin on TANF assistance, including 26% on basic assistance, 0% on child



care, 0% on transportation, and 74% on nonassistance.<sup>23</sup>

- In 2013, \$59,156,387 was spent on WIC (the Special Supplement Nutrition Program for Women, Infants, and Children) in Wisconsin, serving 112,895 participants.<sup>24</sup>
- In 2013, Wisconsin distributed \$620,140,452 in child support funds, a 1.4% increase from 2012.<sup>25</sup>
- In 2013 in Wisconsin, 0 children lived in households with a high housing burden, where more than 30% of monthly income is spent on housing costs.<sup>26</sup>

### CHILD CARE AND HEAD START

- In 2013, Wisconsin had a monthly average of 28,800 children served by subsidized child care; 34,200 children received subsidized child care in 2012 and 28,500 in 2011.<sup>27</sup>
- In 2014, to be eligible for subsidized child care in Wisconsin, a family of three could make no more than \$36,132, which is equivalent to 54% of the state's median income.<sup>28</sup>
- In 2013, Head Start served 12,949 Wisconsin children, a 10.1% decrease from 2012.<sup>29</sup>

#### HEALTH AND SUBSTANCE ABUSE

- In 2014, 466,100 children younger than 19 were enrolled in Medicaid in Wisconsin—65% of the total number of enrollees in the state.<sup>30</sup>
- In 2012, Wisconsin had 169,339 children enrolled in its State Children's Health Insurance Program, a 1.8% decrease from 2011, when 172,451 children were enrolled.<sup>31</sup>
- In 2013, Wisconsin had 61,288 uninsured children.<sup>32</sup>
- In 2012, 4,809 babies were born weighing less than 2,500 grams in Wisconsin.<sup>33</sup>
- In 2011, 427 infants under age 1 died in Wisconsin.<sup>34</sup>
- In 2012, the birth rate for teens 15–17 in Wisconsin was 10 births per 1,000 girls; for teens 18–19, the rate was 38. This reflects a total rate of 22 births per 1,000 girls ages 15–19.<sup>35</sup>
- Cumulative through 2013, 5,738 adults and adolescents, as well as 37 children younger than 13, were reported as having HIV/AIDS in Wisconsin.<sup>36</sup>
- In 2013, an estimated 28,000 children ages 12–17 and 362,000 adults age 18 and older were dependent on or abusing illicit drugs or alcohol in Wisconsin.<sup>37</sup>

#### **VULNERABLE YOUTH**

- In 2011, 462 children aged out of out-of-home care—exited foster care to emancipation—in Wisconsin.<sup>38</sup>
- In 2013, 16,000 Wisconsin teens ages 16–19 were not enrolled in school and were not working.<sup>39</sup>
- In 2013, 65,000 young adults ages 18–24 were not enrolled in school, were not working, and had no degree beyond high school.<sup>40</sup>
- In 2013, approximately 14,000 children ages 12–17 in Wisconsin needed but had not received treatment for illicit drug use in the past year.<sup>41</sup>
- In 2013, approximately 17,000 children ages 12–17 needed but had not received treatment for alcohol use in the past year.<sup>42</sup>
- In 2013, 47 Wisconsin children younger than 20 committed suicide, a rate of 3.2 per 100,000 children.<sup>43</sup>



## JUVENILE JUSTICE AND DELINQUENCY PREVENTION

- In 2013, 38 children under age 19 were killed by a firearm in Wisconsin, a 9.5% decrease from 42 in 2012.<sup>44</sup>
- In 2013, 55,187 children younger than 18 were arrested in Wisconsin, a 13% increase from 63,281 arrests in 2012. Of the arrests in 2013, 1,344 were for violent crimes.<sup>45</sup>
- In 2013, 915 children lived in juvenile correction facilities in Wisconsin.<sup>46</sup>

# CHILD WELFARE WORKFORCE<sup>47</sup>

- A 2003 General Accounting Office (GAO) report documented that staff shortages, high caseloads, high worker turnover and low salaries impinge on delivering services to achieve safety, permanence, and well being for children. In Children's Rights 2009, A Long Road Home report, similar challenges to the child welfare caseworkers were identified, in addition to no standard training or consistent background requirements, need for meaningful supervision, and lack of private workspace, technology and other resources.<sup>48</sup>
- The federal Child and Family Service Reviews have clearly demonstrated that the more time a caseworker spends with a child and family, the better the outcomes for those children and families.<sup>49</sup>
- According to the 2003 GAO report, the average caseload for child welfare/foster care caseworkers is 24–31 children; these high caseloads contribute to high worker turnover and insufficient services being provided to children and families. CWLA recommends that foster care caseworkers have caseloads of 12–15 children.<sup>50</sup>
- The National Association of Social Workers 2012 Document to the Obama Administration called for full funding of the Child Abuse Prevention and Treatment Act (CAPTA) and Promoting Safe and Stable Families (PSSF), protection of the Social Security Block Grant (SSBG) from budget cuts and elimination, a variety of child maltreatment prevention services to be available through programs serving children and families (e.g., TANF, Head Start, etc.), maximization of collaboration amongst different systems (e.g., Child Welfare, Public Health, Juvenile Justice, etc.) to improve integration, culturally and linguistically appropriate delivery of services, identification and implementation of evidence-based practices, and incentivization of BSW and MSW students to join the child welfare workforce.<sup>51</sup>

#### FUNDING CHILD WELFARE SERVICES FOR WISCONSIN'S CHILDREN

- In 2012, Wisconsin spent \$458,294,127 for child welfare services. Child welfare services are all direct and administrative services the state agency provides to children and families. Of this amount, \$170,895,066 was from federal funds, \$196,158,321 from state funds, and \$91,240,740 from local funds.<sup>52</sup>
- In 2012, of the \$170,895,066 in federal funds received for child welfare, 61.5% was from Title IV-E Foster Care and Adoption Assistance, 5.4% came from Title IV-B Child Welfare Services and Promoting Safe and Stable Families, 10.0% was from Medicaid, 6.2% came from Social Services Block Grant, 14.0% was from TANF, and 2.9% came from other federal sources.<sup>53</sup>
- Wisconsin received \$52,445,186 in federal funds for IV-E foster care expenditures in 2012, including \$20,138,736 for maintenance payments and \$32,306,450 for administration, child placement, the statewide automated child welfare information system, and training.<sup>54</sup>
