



The Proposed Increase Difference Between House/Senate COVID-19 Bills (Bill Number 5)

These programs and funding sources represent a small piece of what is being debated in Washington DC. There are many additional issues such as small business/non-profit relief, nutrition programs, education funds child tax credits and specific housing relief that will have an impact on children and families and child welfare overall. This chart is focused on some of the most immediate child welfare related matters.
