

# Kentucky's Children 2022

## Child Maltreatment

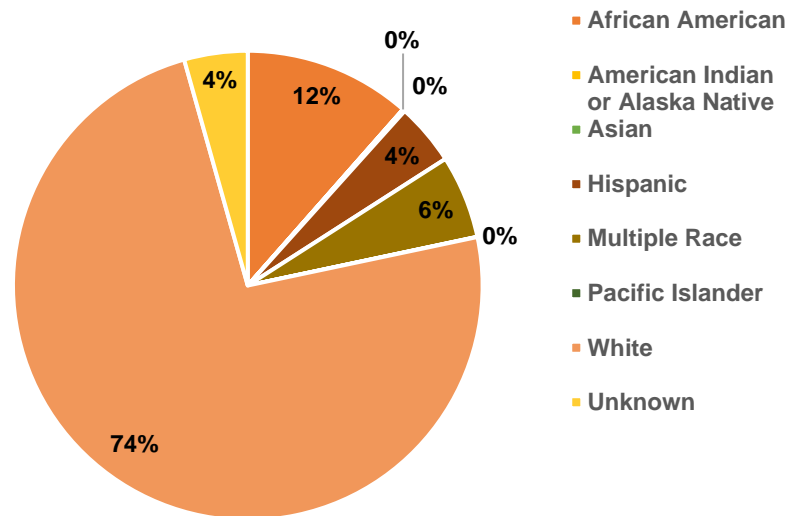
In 2020, Kentucky had **95,378** total referrals for child abuse and neglect. Of those, **46,270** were referred for investigation.<sup>i</sup>

There were **16,748** child victims of abuse or neglect in Kentucky in 2020, at a rate of **16.7** children per 1,000. This translates to a **16.3%** decrease since 2016.<sup>ii</sup>

Of the **16,748** children, **10,732** were first time victims.<sup>iii</sup>

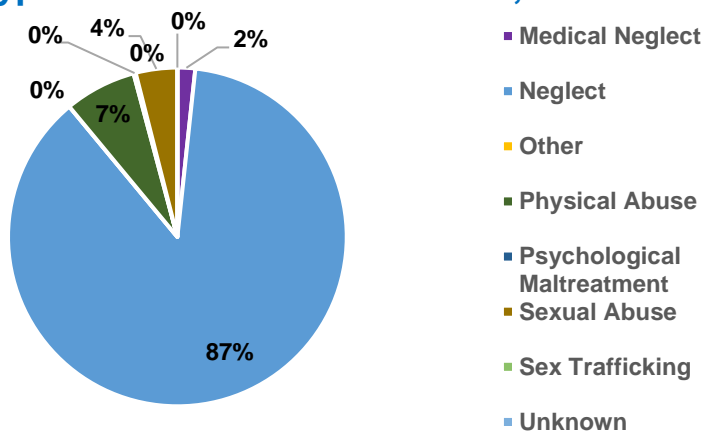
The largest age group of victims was children under one, representing **2,493** of the **16,748** cases.<sup>iv</sup>

## Types of Maltreatment Victims, 2020



- **76%** of child maltreatment perpetrators in 2020 were parents of the child. **24%** were non-parents or had an unknown relationship.<sup>vi</sup>

- **50%** of Kentucky's child victims in 2020 were female while **49%** were male.<sup>vii</sup>

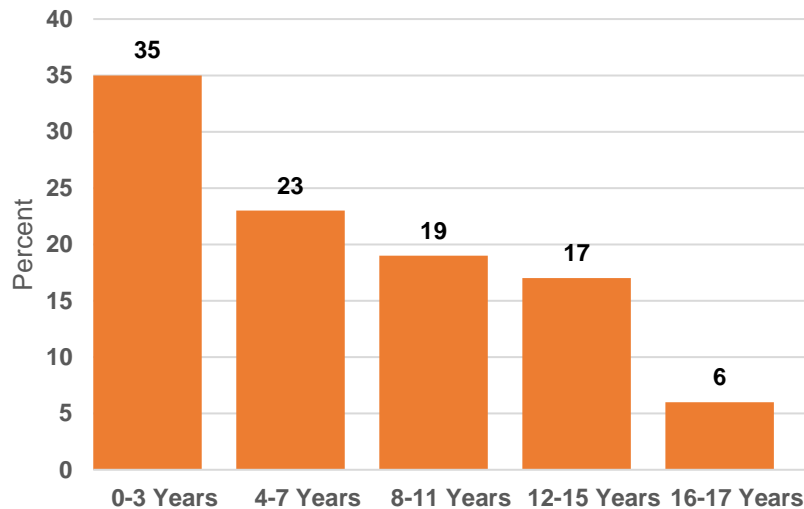
## Plans of Safe Care

- In 2020, Kentucky reported **1,150** infants who were screened-in with prenatal substance abuse exposure.<sup>ix</sup>
- Kentucky reported **228** plans of safe care for screened-in infants.<sup>x</sup>



# Kentucky's Children 2022

## Age Distribution of Maltreatment Victims, 2020



• Child fatalities decreased in 2020 from **12** in 2019 to **nine** in 2020.<sup>xi</sup>

• Kentucky reported **zero** number for child victims of sex trafficking.<sup>xii</sup>

• **12,694** victims received post-response services while **4,320** non-victims received post-response services as well.<sup>xiii</sup>

## Foster Care and Adoptions

- **14,219** total children were served by the foster care system in FY 2020.
- **8,675** were in care on the day of September 30<sup>th</sup>, 2020.
- **5,204** children entered care during the 2020 FY while **5,544** exited during the same year.
- **1,365** of Kentucky's children were adopted while **3,302** were waiting to be adopted.<sup>xv</sup>

There was a **5.2%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system also decreased **0.2%** from 2019.<sup>xvi</sup>

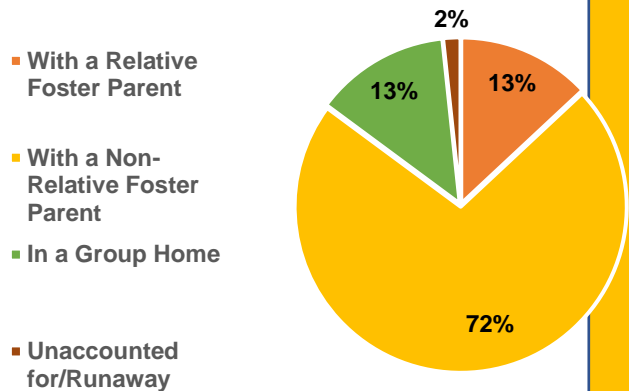
**706** children in Kentucky aged out and exited foster care in 2019. This is an increase from **667** in 2018 and represents an **5.8%** increase.<sup>xvii</sup>

- Children in foster care in 2020 spent an average of **19.1** months in care.<sup>xviii</sup>
- The average length of stay in Kentucky for children waiting to be adopted from foster care is **31.5** months.<sup>xix</sup>
- The average age of children waiting to be adopted in 2020 was **9.1** years old.<sup>xx</sup>
- The average age of adopted children was **7.3** years old.<sup>xxi</sup>

## Where are Children in Foster Care Staying?



Data from 2019 shows that **6,138** children in foster care within Kentucky were living with non-relatives while **1,111** stayed with a relative (See Pie Chart).<sup>xxii</sup>

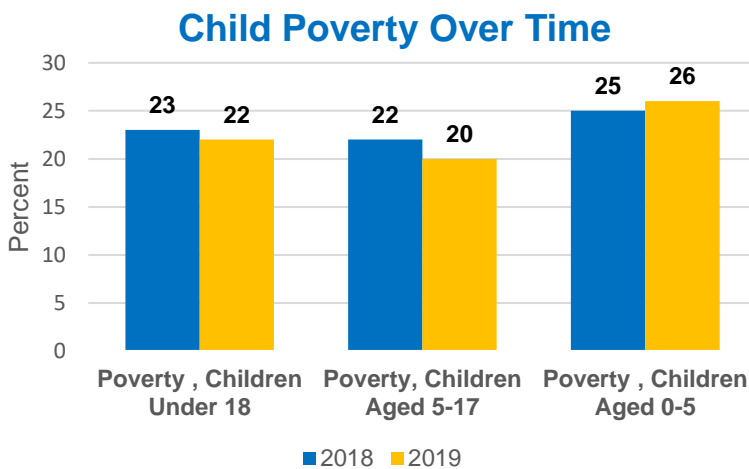
**1,123** children were staying in group homes while **143** children were classified as runaways.<sup>xxiii</sup>

**4%** of households in Kentucky in 2020 had a grandparent living with a grandchild.<sup>xxiv</sup>

The average length of time a child in care spent living with their current relative foster family was **9.4** months.<sup>xxv</sup>

## Child Poverty

Kentucky had **307,000** children in 2019 who lived with parents who lacked secure employment, representing **31%** of all children.<sup>xxvi</sup>

**23%** of Kentucky's children lived in households with a high housing cost burden.<sup>xxviii</sup>

The average number of individuals receiving TANF fell from **34,817** in 2019 to **31,318** in 2020. This represents a **10.05%** decrease.<sup>xxix</sup>

The state spent **\$46,398,321** on WIC in 2021, serving **107,477** people. This represents a **9.6%** increase in total participants and a **4.2%** increase in spending.<sup>xxxi</sup>

**644,540** people in Kentucky were food insecure in 2019, including **179,030** children who struggled with hunger.<sup>xxxii</sup>

**40.6%** of households receiving SNAP benefits in Kentucky in 2019 had children.<sup>xxxiii</sup>

## Health

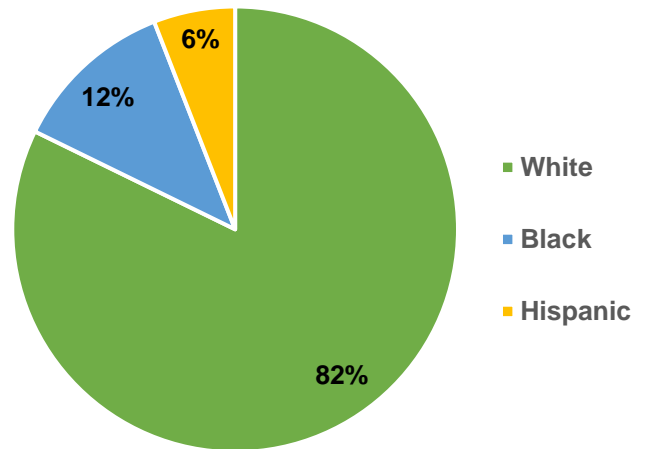
Kentucky had **4,642** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **8.7%** of infants born in Kentucky in 2019.<sup>xxxiv</sup>

Kentucky had a total of **5,993** preterm births in 2019, meaning less than 37 completed weeks of gestation. **11.16%** of all white babies were born premature while **13.48%** of black babies arrived prematurely in 2019. The total premature birth rate was **11.30%**.<sup>xxxv</sup>

There were **3,464** births to mothers aged 15-19 in Kentucky in 2019, representing a rate of **25** in every 1,000 teen girls.<sup>xxxvi</sup>

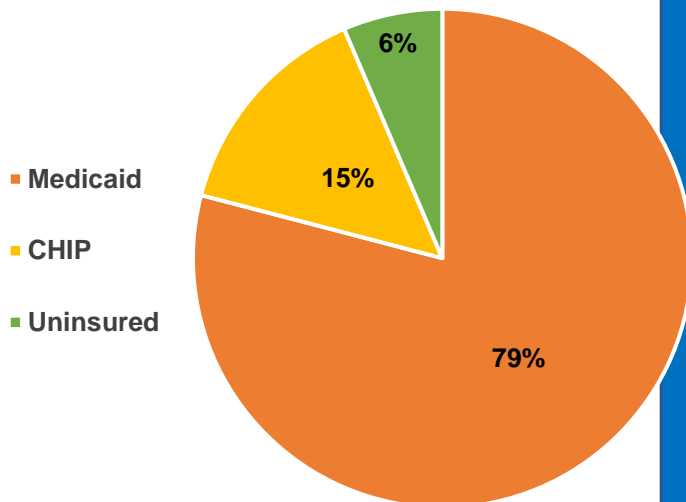
**266** infants under one died in Kentucky in 2019, representing an infant mortality rate of **5.0** per 1,000.<sup>xxxvii</sup>

Public Health Insurance Coverage for Children, 2020



**4.3%** of Kentucky's children had no health insurance in 2019. This represents **45,000** children. Kentucky is a Medicaid expansion state.<sup>xxxix</sup>

**552,593** children in Kentucky were enrolled in Medicaid in 2020. This represents **4.02%** increase from 2019.<sup>xl</sup>

**101,275** children in Kentucky were in the state Children Health Insurance Program (CHIP) in 2020. This represents an **6.5%** decrease from 2019.<sup>xli</sup>

## Juvenile Justice System

- There were **4,798** total arrests for children under 18 in Kentucky in 2019.
- **164** of these arrests were for Disorderly Conduct.
- **1,193** arrests were made for Property Crimes.
- **398** were arrested under the charge of Drug Abuse Violations.<sup>xlii</sup>
- **588** children lived in juvenile correction facilities in Kentucky in 2019. This is an increase from **555** kids in 2017, representing a **5.9%** increase.<sup>xliii</sup>

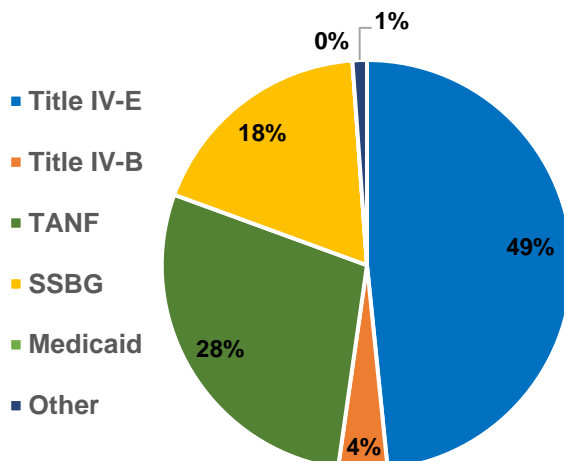
## Teens & Youth

- **18,000** (8%) of Kentucky's youth were both not in school and not working in 2019.<sup>xliv</sup>
- In 2020, there were **11** reports of children in Kentucky aged 10-14 committing suicide, and **35** reports of suicide among children aged 15-19.<sup>xlv</sup>
- **97** children under age 19 were killed by a firearm in Kentucky in 2020.<sup>xlvi</sup>

## Child Welfare Services Funding

- Kentucky spent **\$662,021,397** on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families.
- **\$241,832,117** were allocated from the federal government and **\$405,805,140** came from state and local funds.<sup>xlvii</sup>

The breakdown of the **\$241,832,117** in federal funding received in Kentucky in 2018:<sup>xlviii</sup>

- **\$54,559,754** as part of the Title IV-E Foster Care Program.
- **\$56,590,366** as part of the Title IV-E Adoption Assistance Program.<sup>xlix</sup>
- Kentucky's sum of expenditures for Social Service Block Grants in 2020 was **\$22,293,352.**<sup>l</sup>
