
In 2020, Maryland had **58,149** total referrals for child abuse and neglect. Of those, **19,997** were referred for investigation.ⁱ

There were **7,242** child victims of abuse or neglect in Maryland in 2020, at a rate of **5.4** children per 1,000. This translates to a **3.6%** increase since 2016.ⁱⁱ

Of the **7,242** children, **4,661** were first time victims.ⁱⁱⁱ

The largest age group of victims was children under one, representing **565** of the **7,242** cases.^{iv}

Plans of Safe Care

- In 2020, Maryland reported **zero** infants who were screened-in with prenatal substance abuse exposure.^{ix}
- Maryland reported zero plans of safe care for screened-in infants.^x

• Child fatalities decreased in 2020 from **55** in 2019 to **50** in 2020.^{xi}

• Maryland did not report any numbers regarding child victims of sex trafficking.^{xii}

•1,306 victims received post-response services while 1,320 non-victims received post-response services as well.^{xiii}

Foster Care and Adoptions

- **5,159** total children were served by the foster care system in FY 2020.
- **3,800** were in care on the day of September 30th, 2020.
- **1,705** children entered care during the 2020 FY while **1,359** exited during the same year.
- **237** of Maryland's children were adopted while **347** were waiting to be adopted.^{xv}

There was a **1.04%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system also decreased **18.6%** from 2019.^{xvi}


11.3% Decrease since 2018 in children aging out of foster care

345 children in Maryland aged out and exited foster care in 2019. This is a decrease from **389** in 2018 and represents an **11.3%** decrease.^{xvii}

- Children in foster care in 2020 spent an average of 23.1 months in care. xviii
- The average length of stay in Maryland for children waiting to be adopted from foster care in 2020 was 41.8 months.^{xix}
- The average age of children waiting to be adopted in 2020 was 7.1 years old.^{xx}
- The average age of adopted children was 5.1 years old.xxi

Data from 2019 shows that **1,399** children in foster care within Maryland were living with non-relatives while **1,591** stayed with a relative (See Pie Chart).^{xxii}


558 children were staying in group homes while **29** children were classified as runaways.^{xxiii}

4% of households in Maryland in 2020 had a grandparent living with a grandchild.^{xxiv}

The average length of time a child in care spent living with their current relative foster family was **12.3** months.^{xxv}

Child Poverty

Maryland had **315,000** children in 2019 who lived with parents who lacked secure employment, representing **24%** of all children.^{xxvi}

31% of Maryland's children lived in households with a high housing cost burden.^{xxviii}

The average number of individuals receiving TANF rose from **40,560** in 2019 to **50,278** in 2020. This represents a **24.0%** increase.^{xxix xxx}

The state spent **\$44,063,297** on WIC in 2021, serving **119,658** people. This represents a **2.34%** decrease in total participants and a **9.04%** decrease in spending. ^{xxxi}

640,180 people in Maryland were food insecure in 2019, including **195,960 children** who struggled with hunger.^{xxxii}

37.1% of households receiving SNAP benefits in Maryland in 2019 had children.xxxiii


Maryland had **6,111** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **8.7%** of infants born in Maryland in 2019.^{xxxiv}

Maryland had a total of **7,211** preterm births in 2019, meaning less than 37 completed weeks of gestation. **8.85%** of all white babies were born premature while **13.10%** of black babies arrived prematurely in 2019. The total premature birth rate was **10.28%.**^{xxxv}


There were **2,603** births to mothers aged 15-19 in Maryland in 2019, representing a rate of **14** in every 1,000 teen girls. ^{xxxvi}

413 infants under one died in Maryland in 2019, representing an infant mortality rate of **5.9** per 1,000. ^{xxxvii}

3.4% of Maryland's children had no health insurance in 2019. This represents **48,000** children. Maryland is a Medicaid expansion state.^{xxxix}

564,993 children in Maryland were enrolled in Medicaid in 2020. This represents **2.62%** increase from 2019. ^{xl}

131,725 children in Maryland were in the state Children Health Insurance Program (CHIP) in 2020. This represents an **11.1%** decrease from 2019. ^{xli}

Juvenile Justice System

- There were **18,857** total arrests for children under 18 in Maryland in 2019.
- 990 of these arrests were for Disorderly Conduct.
- **3,950** arrests were made for Property Crimes.
- **1,831** were arrested under the charge of Drug Abuse Violations.^{xlii}


• **495** children lived in juvenile correction facilities in Maryland in 2019. This is a decrease from **549** kids in 2017, representing a **9.8%** decline.^{xliii}

Teens & Youth

- 21,000 (7%) of Maryland's youth were both not in school and not working in 2019.^{xliv}
- In 2020, there were 11 reports of children in Maryland aged 10-14 committing suicide, and 29 reports of suicide among children aged 15-19.^{xlv}
- 73 children under age 19 were killed by a firearm in Maryland in 2020.xlvi

Child Welfare Services Funding

- Maryland spent **\$526,958,509** on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families.
- \$148,450,598 were allocated from the federal government and \$373,057,952 came from state and local funds.^{xlvii}

- **\$3,154,899** as part of the Title IV-E Foster Care Program.
- **\$20,649,356** as part of the Title IV-E Adoption Assistance Program.^{xlix}
- Maryland's sum of expenditures for Social Service Block Grants in 2020 was \$52,392,096.¹
