

# Michigan's Children 2022

## Child Maltreatment

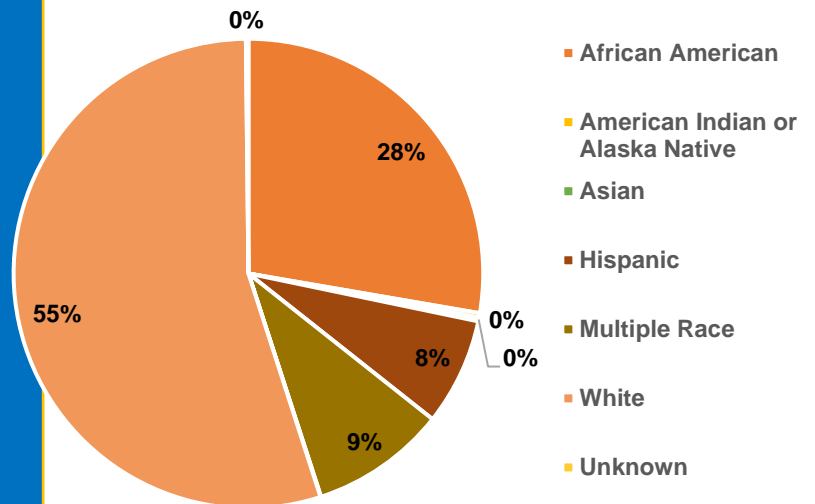
In 2020, Michigan had **140,748** total referrals for child abuse and neglect. Of those, **72,953** were referred for investigation.<sup>i</sup>

There were **26,932** child victims of abuse or neglect in Michigan in 2020, at a rate of **12.7** children per 1,000. This translates to a **27.7%** decrease since 2016.<sup>ii</sup>

Of the **26,932** children, **16,859** were first time victims.<sup>iii</sup>

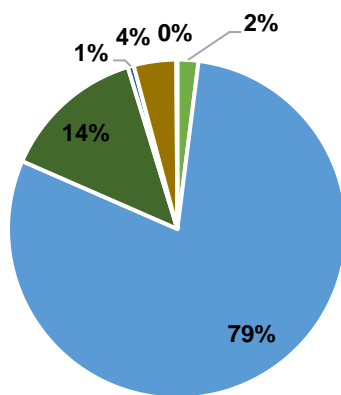
The largest age group of victims was children under one, representing **3,430** of the **26,932** cases.<sup>iv</sup>

## Types of Maltreatment Victims, 2020

- **77%** of child maltreatment perpetrators in 2020 were parents of the child. **23%** were non-parents or had an unknown relationship.<sup>vi</sup>

- **50%** of Michigan's child victims in 2020 were female while **50%** were male.<sup>vii</sup>

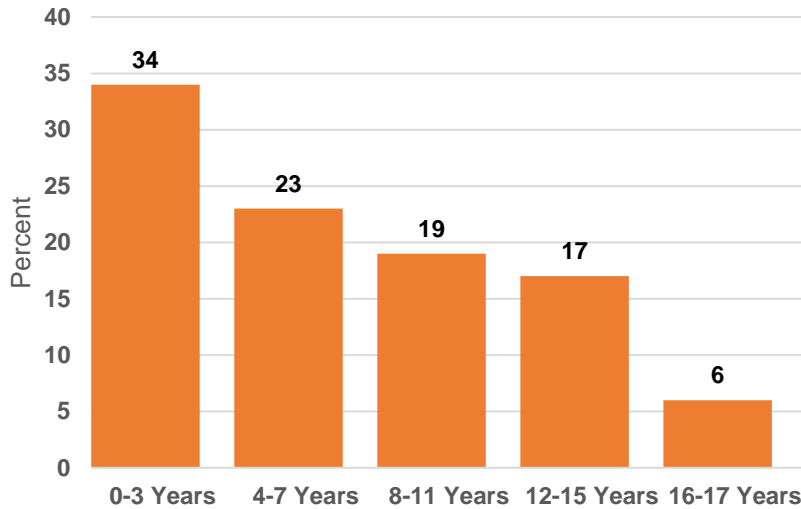
## Plans of Safe Care

- In 2020, **6,370** infants were screened-in with prenatal substance abuse exposure.<sup>ix</sup>
- Michigan reported **6,101** plans of safe care for screened-in infants.<sup>x</sup>

## Age Distribution of Maltreatment Victims, 2020



• Child fatalities decreased in 2020 from **63** in 2019 to **43** in 2020.<sup>xi</sup>

• Michigan reported **28** total child victims of sex trafficking.<sup>xii</sup>

• **7,169** victims received post-response services while **10,689** non-victims received post-response services as well.<sup>xiii</sup>

## Foster Care and Adoptions

- **16,021** total children were served by the foster care system in FY 2020.
- **10,661** were in care on the day of September 30<sup>th</sup>, 2020.
- **4,386** children entered care during the 2020 FY while **5,360** exited during the same year.
- **1,851** of Michigan's children were adopted while **3,660** were waiting to be adopted.<sup>xv</sup>

There was a **8.7%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system also decreased **14.3%** from 2019.<sup>xvi</sup>

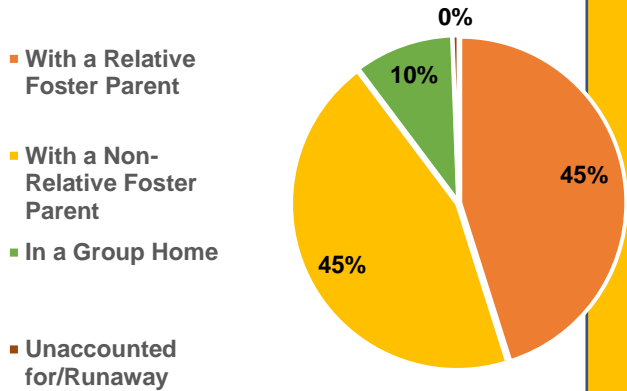
**640** children in Michigan aged out and exited foster care in 2019. This is a decrease from **706** in 2018 and represents a **9.3%** decrease.<sup>xvii</sup>

- Children in foster care in 2020 spent an average of **21.2** months in care.<sup>xviii</sup>
- The average length of stay in Michigan for children waiting to be adopted from foster care is **30.6** months.<sup>xix</sup>
- The average age of children waiting to be adopted in 2020 was **7.6** years old.<sup>xx</sup>
- The average age of adopted children was **6.0** years old.<sup>xxi</sup>

## Where are Children in Foster Care Staying?



Data from 2019 shows that **4,550** children in foster care within Michigan were living with non-relatives while **4,600** stayed with a relative (See Pie Chart).<sup>xxii</sup>

**986** children were staying in group homes while **59** children were classified as runaways.<sup>xxiii</sup>

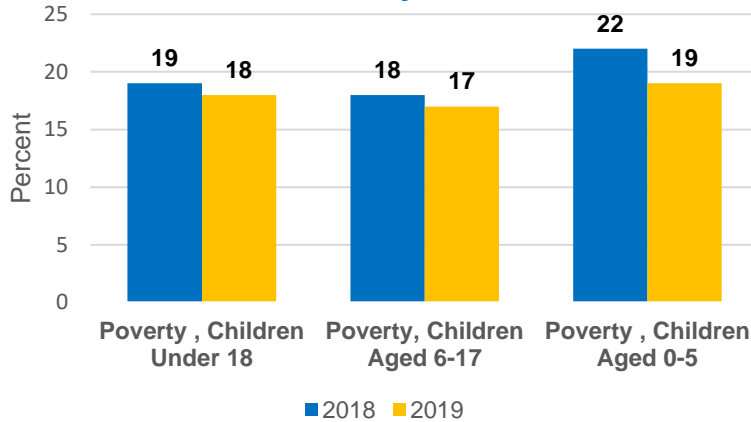
**3%** of households in Michigan in 2020 had a grandparent living with a grandchild.<sup>xxiv</sup>

The average length of time a child in care spent living with their current relative foster family was **10.0** months.<sup>xxv</sup>

## Child Poverty

Michigan had **556,000** children in 2019 who lived with parents who lacked secure employment, representing **26%** of all children.<sup>xxvi</sup>

**24%** of Michigan's children lived in households with a high housing cost burden.<sup>xxviii</sup>

The average number of individuals receiving TANF rose from **27,888** in 2019 to **34,944** in 2020. This represents a **25.3%** increase.<sup>xxix</sup>

The state spent **\$67,786,322** on WIC in 2021, serving **207,317** people. This represents a **3.07%** decrease in total participants and a **15.5%** decrease in spending.<sup>xxxii</sup>

**1,299,020** people in Michigan were food insecure in 2019, including **305,190** children who struggled with hunger.<sup>xxxii</sup>

**33.8%** of households receiving SNAP benefits in Michigan in 2019 had children.<sup>xxxiii</sup>

## Health

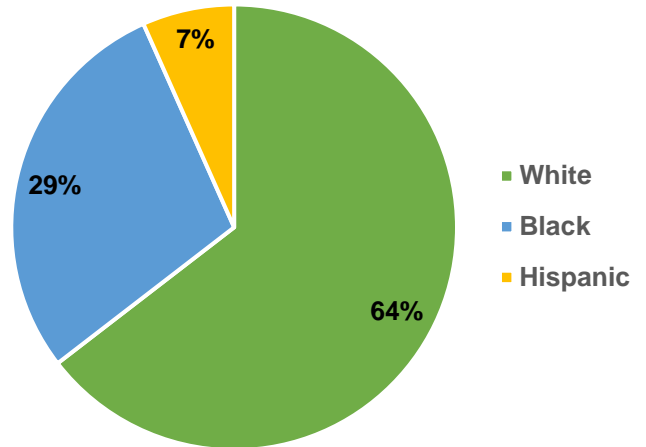
Michigan had **9,414** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **8.7%** of infants born in Michigan in 2019.<sup>xxxiv</sup>

Michigan had a total of **11,070** preterm births in 2019, meaning less than 37 completed weeks of gestation. **9.19%** of all white babies were born premature while **14.69%** of black babies arrived prematurely in 2019. The total premature birth rate was **10.27%**.<sup>xxxv</sup>

There were **4,758** births to mothers aged 15-19 in Michigan in 2019, representing a rate of **15** in every 1,000 teen girls.<sup>xxxvi</sup>

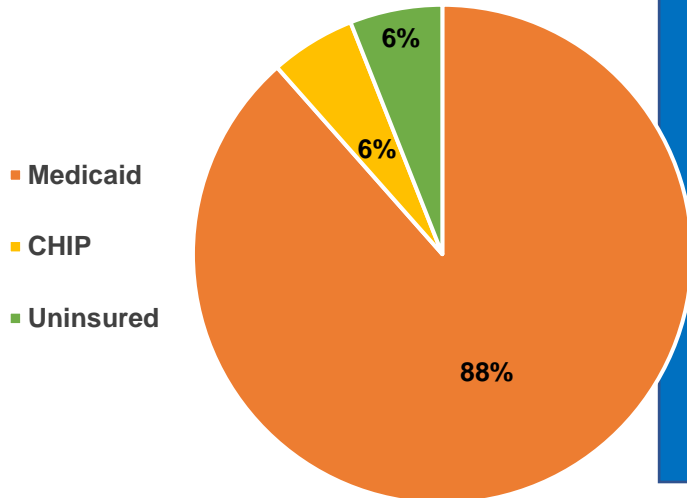
**690** infants under one died in Michigan in 2019, representing an infant mortality rate of **6.4** per 1,000.<sup>xxxvii</sup>

Public Health Insurance Coverage for Children, 2020



**3.4%** of Michigan's children had no health insurance in 2019. This represents **78,000** children.<sup>xxxix</sup>

**1,150,183** children in Michigan were enrolled in Medicaid in 2020. This represents a **2.1%** decrease from 2019.<sup>xl</sup>

**71,853** children in Michigan were in the state Children's Health Insurance Program (CHIP) in 2020. This represents a **18.3%** decrease from 2019.<sup>xli</sup>

## Juvenile Justice System

- There were **11,172** total arrests for children under 18 in Michigan in 2019.
- **408** of these arrests were for Disorderly Conduct.
- **2,646** arrests were made for Property Crimes.
- **403** were arrested under the charge of Drug Abuse Violations.<sup>xlii</sup>
- **1,353** children lived in juvenile correction facilities in Michigan in 2019. This is an increase from **1,260** kids in 2017, representing an **7.4%** incline.<sup>xliii</sup>

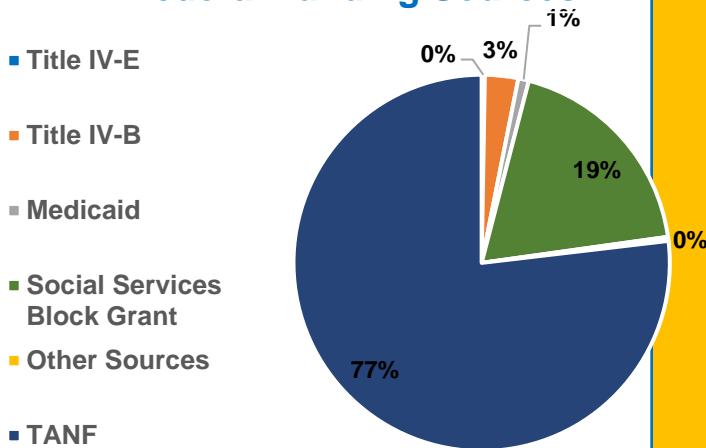
## Teens & Youth

- **31,000** (6%) of Michigan's youth were both not in school and not working in 2019.<sup>xliv</sup>
- In 2020, there were **14** reports of children in Michigan aged 10-14 committing suicide, and **62** reports of suicide among children aged 15-19.<sup>xlv</sup>
- **117** children under age 19 were killed by a firearm in Michigan in 2020.<sup>xlvi</sup>

## Child Welfare Services Funding

- Michigan spent **\$1,281,121,489** on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families.
- **\$853,527,106** were allocated from the federal government and **\$424,266,810** came from state and local funds.<sup>xlvii</sup>
