Child Maltreatment

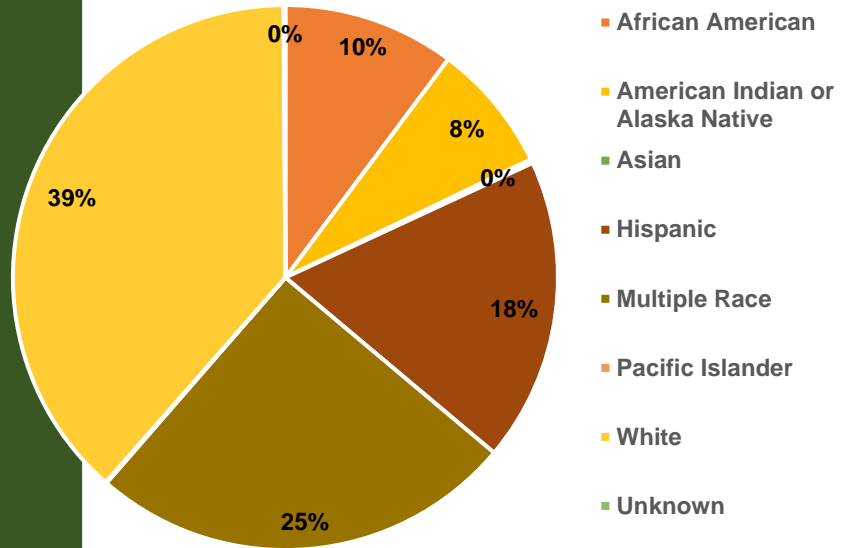
In 2020, Oklahoma had **76,309** total referrals for child abuse and neglect. Of those, **37,398** were referred for investigation.ⁱ

There was **14,685** child victims of abuse or neglect in Oklahoma in 2020, at a rate of **15.4** children per 1,000. This translates to a **2.6%** increase since 2016.ⁱⁱ

Of the **14,685** children, **11,374** were first time victims.ⁱⁱⁱ

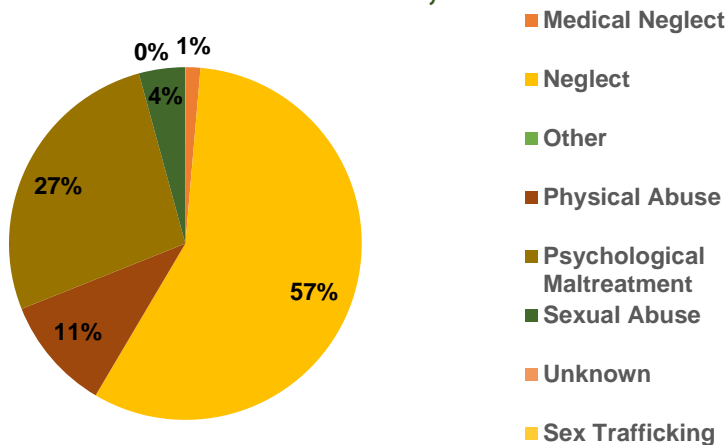
The largest age group of victims was children under one, representing **2,435** of the **14,685** cases.^{iv}

Types of Maltreatment Victims, 2020



- **80%** of child maltreatment perpetrators in 2020 were parents of the child. **20%** were non-parents or had an unknown relationship.^{vi}

- **51%** of Oklahoma's child victims in 2020 were female while **49%** were male.^{vii}

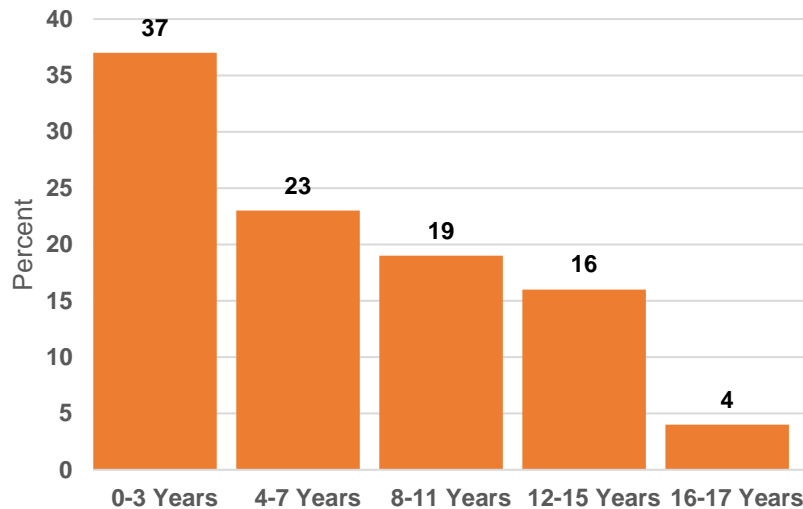
Plans of Safe Care

- In 2020, Oklahoma reported **2,218** infants who were screened-in with prenatal substance abuse exposure.^{ix}
- Oklahoma reported **71** plans of safe care for screened-in infants.^x

Age Distribution of Maltreatment Victims, 2020



- Child fatalities increased from **23** in 2019 to **42** in 2020.^{xi}

- Oklahoma reported **four** total child victims of sex trafficking.^{xii}

- **13,475** victims received post-response services while **36,175** non-victims received post-response services as well.^{xiii}

Foster Care and Adoptions

- **12,325** total children were served by the foster care system in FY 2020.
- **8,052** were in care on the day of September 30th, 2020.
- **4,045** children entered care during the 2020 FY while **4,273** exited during the same year.
- **1,820** of Oklahoma's children were adopted while **3,614** were waiting to be adopted.^{xv}

There was a **3.1%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system also decreased **12.7%** from 2019.^{xvi}

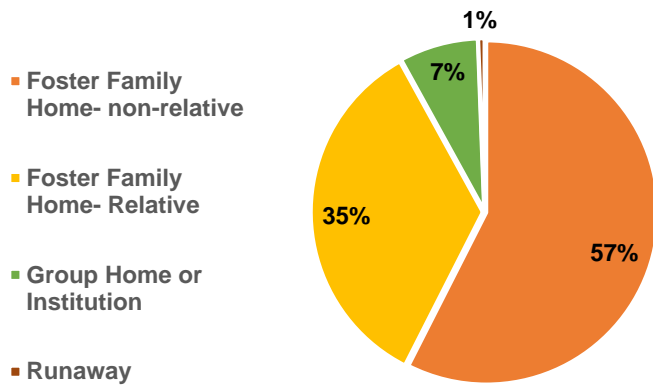
171 children in Oklahoma aged out and exited foster care in 2019. This is a decrease from **203** in 2018 and represents a **15.7%** decrease.^{xvii}

- Children in foster care in 2020 spent an average of **18.5** months in care.^{xviii}
- The average length of stay in Oklahoma of children waiting to be adopted from foster care in **27.2** months.^{xix}
- The average age of children waiting to be adopted in 2020 was **6.8** years old.^{xx}
- The average age of adopted children was **6.1** years old.^{xxi}

Where are Children in Foster Care Staying?



Data from 2019 shows that **4,075** children in foster care within Oklahoma were living with non-relatives while **2,446** stayed with a relative (See Pie Chart).^{xxii}

526 children were staying in group homes while **42** children were classified as runaways.^{xxiii}

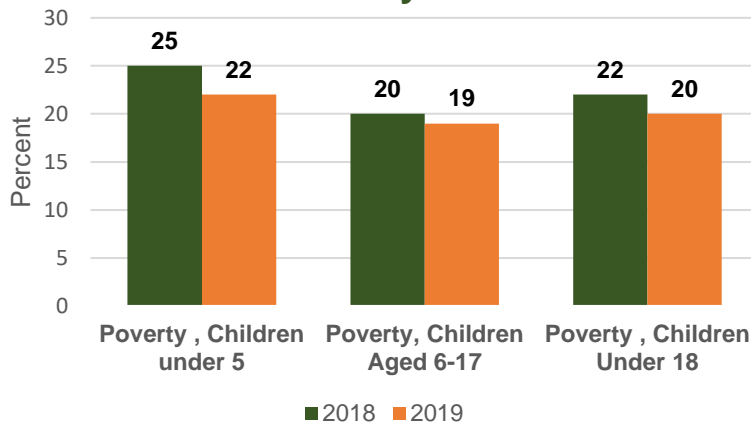
4% of households in Oklahoma in 2020 had a grandparent living with a grandchild.^{xxiv}

The average length of time a child in care spent living with their current relative foster family was **10.6** months.^{xxv}

Child Poverty

Oklahoma had **244,000** children in 2019 who lived with parents who lacked secure employment, representing **26%** of all children.^{xxvi xxvii}

Child Poverty Over Time



25% of Oklahoma's children lived in households with a high housing cost burden.^{xxviii}

The average number of individuals receiving TANF decreased from **13,304** in 2019 to **12,607** in 2020. This represents a **5.2%** decrease.^{xxix xxx}

The state spent **\$27,717,191** on WIC in 2021, serving **88,632** people. This represents a **3.3%** decrease in total participants and a **16.5%** decrease in spending.^{xxxii}

583,570 people in Oklahoma were food insecure in 2019, including **194,880** children who struggled with hunger.^{xxxiii}

45.2% of households receiving SNAP benefits in Oklahoma in 2019 had children.^{xxxiiii}

Health

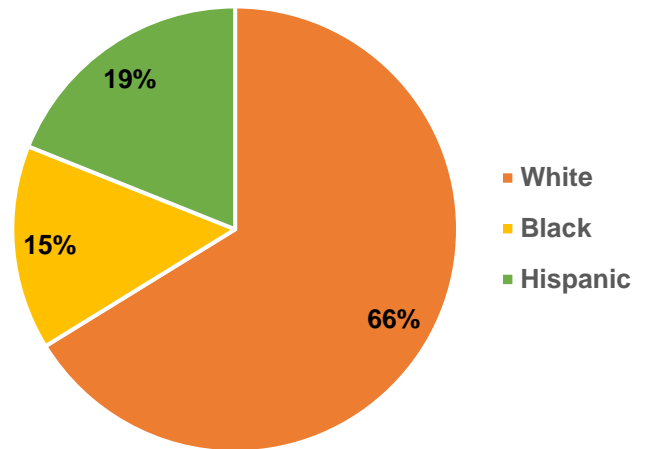
Oklahoma had **4,045** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **8.2%** of infants born in Oklahoma in 2019.^{xxxiv}

Oklahoma had a total of **5,646** preterm births in 2019, meaning less than 37 completed weeks of gestation. **10.7%** of all white babies were born premature while **16.2%** of black babies arrived prematurely in 2019. The total premature birth rate was **11.4%**.^{xxxv}

There were **3,520** births to mothers aged 15-19 in Oklahoma in 2019, representing a rate of **27** in every 1,000 teen girls.^{xxxvi}

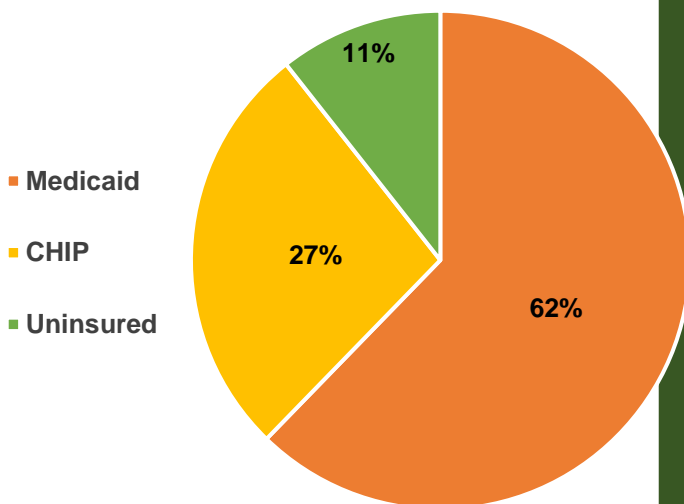
343 infants under 1 died in Oklahoma in 2019, representing an infant mortality rate of **7.0** per 1,000.^{xxxvii}

Public Health Insurance Coverage for Children, 2020



8.6% of Oklahoma's children had no health insurance in 2019. This represents **86,000** children.^{xxxix}

504,439 children in Oklahoma were enrolled in Medicaid in 2020. This represents a **0.6%** decrease from 2019.^{xl}

219,541 children in Oklahoma were in the state Children's Health Insurance Program (CHIP) in 2020. This represents a **4.1%** increase from 2019.^{xli}

Juvenile Justice System

- There were **7,195** total arrests for children under 18 in Oklahoma in 2019.
- **552** of these arrests were for Disorderly Conduct.
- **1,513** arrests were made for Property Crimes.
- **1,022** were arrested under the charge of Drug Abuse Violations.^{xlii}
- **345** children lived in juvenile correction facilities in Oklahoma in 2019. This is a decrease from **426** kids in 2017, representing a **19.0%** decrease.^{xliii}

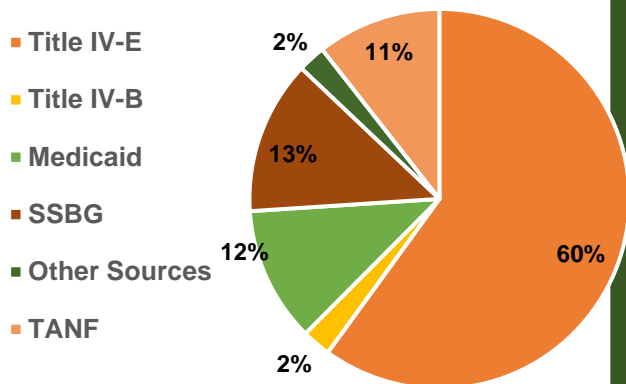
Teens & Youth

- **18,000** (8%) of Oklahoma's youth were both not in school and not working in 2019.^{xliv}
- In 2020, there were **18** reports of children in Oklahoma aged 10-14 committing suicide; and **51** reports of suicide among children aged 15-19.^{xlv}
- **73** children under age 19 were killed by a firearm in Oklahoma in 2020.^{xlvi}

Child Welfare Services Funding

- Oklahoma spent **\$480,226,117** on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families.
- **\$222,224,594** were allocated from the federal government and **\$253,389,367** came from state and local funds.^{xlvii}

The breakdown of the **\$222,224,594** in federal funding received in Oklahoma in 2018:^{xlviii}

- **\$180,935,732** as part of the Title IV-E Foster Care Program.
- **\$67,510,922** as part of the Title IV-E Adoption Assistance Program^{xlix}
- Oklahoma's sum of expenditures for Social Service Block Grants in 2020 was **\$32,998,531**^l
