Child Maltreatment


In 2020, South Dakota had **14,131** total referrals for child abuse and neglect. Of those, **2,449** were referred for investigation.

There were **1,570** child victims of abuse or neglect in South Dakota in 2020, at a rate of **7.2** children per 1,000. This translates to a **26.0%** increase since 2016.ⁱⁱ


Of the **1,570** children, **1,238** were first time victims.ⁱⁱⁱ

The largest age group of victims was children under one, representing **254** of the **1,570** cases.iv

79% of child maltreatment perpetrators in 2020 were parents of the child. **21%** were non-parents or had an unknown relationship.vi

52% of South Dakota's child victims in 2020 were female and **48%** were male.^{vii}



Plans of Safe Care

- In 2020, South Dakota reported **30** infants who were screened-in with prenatal substance abuse exposure.^{ix}
- South Dakota reported 13 plans of safe care for screened-in infants.x

Child fatalities increased from **nine** in 2019 to **12** in 2020.xi

South Dakota reported **one** total child victim of sex trafficking.xii

851 victims received postresponse services while **286** non-victims received postresponse services as well.xiii

Foster Care and Adoptions

- **2,791** total children were served by the foster care system in FY 2020.
- 1,683 were in care on the day of September 30th, 2020.
- 1,115 children entered care during the 2020 FY while 1,108 exited during the same year.
- 209 of South Dakota's children were adopted while 446 were waiting to be adopted.xv

There was a **1.3%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system decreased **0.9%** from 2019.^{xvi}


Increase since 2018 in children aging out of foster care

62 children in South Dakota aged out and exited foster care in 2019. This is an increase from **57** in 2018 and represents an **8.7%** increase.^{xvii}

- Children in foster care in 2020 spent an average of 18.2 months in care. xviii
- The average length of stay in South Dakota for children waiting to be adopted from foster care is **33.6** months.xix
- The average age of children waiting to be adopted in 2020 was 8.3 years old.xx
- The average age of adopted children was 6.1 years old.xxi

Data from 2019 shows that **794** children in foster care within South Dakota were living with non-relatives while **456** stayed with a relative (See Pie Chart).xxii


240 children were staying in group homes while **14** children were classified as runaways.^{xxiii}

4% of households in South Dakota in 2020 had a grandparent living with a grandchild.^{xxiv}

The average length of time a child in care spent living with their current relative foster family was **7.6** months.**xv

Child Poverty

South Dakota had **48,000** children in 2019 who lived with parents who lacked secure employment, representing **22%** of all children.^{xxvii}



21% of South Dakota's children lived in households with a high housing cost burden. xxviii

The average number of individuals receiving TANF decreased from **5,808** in 2019 to **5,596** in 2020. This represents a **3.6%** decrease.xxix xxx

The state spent \$6,349,852 on WIC in 2021, serving 15,896 people. This represents a 1.4% increase in total participants and a 15.4% decrease in spending. XXXI

91,510 people in South Dakota were food insecure in 2019, including **32,860 children** who struggled with hunger.xxxii

45.8% of households receiving SNAP benefits in South Dakota in 2019 had children.xxxiii



Health


South Dakota had **802** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **7.0%** of infants born in South Dakota in 2019.**

South Dakota had a total of **1,093** preterm births in 2019, meaning less than 37 completed weeks of gestation. **8.7%** of all white babies were born premature while **11.1%** of black babies arrived prematurely in 2019. The total premature birth rate was **9.5%.******

There were **536** births to mothers aged 15-19 in South Dakota in 2019, representing a rate of **19** in every 1,000 teen girls. xxxvi


80 infants under 1 died in South Dakota in 2019, representing an infant mortality rate of **7.0** per 1,000. **xxxvii*

7.8% of South Dakota's children had no health insurance in 2019. This represents **18.000** children.xxxix

69,621 children in South Dakota were enrolled in Medicaid in 2020. This represents **7.4%** decrease from 2019.xl

16,552 children in South Dakota were in the state Children's Health Insurance Program (CHIP) in 2020. This represents a **16.8%** decrease from 2019. xli

Juvenile Justice System

- There were **4,791** total arrests for children under 18 in South Dakota in 2019.
- 476 of these arrests were for Disorderly Conduct.
- **546** arrests were made for Property Crimes.
- **754** were arrested under the charge of Drug Abuse Violations.*Xlii
- 171 children lived in juvenile correction facilities in South Dakota in 2018. This is a increase from 150 kids in 2017, representing a 14.0% increase.xliii


Teens & Youth

- 2,000 (5%) of South Dakota's youth were both not in school and not working in 2019.^{xliv}
- In 2020, South Dakota did not report any suicides for children aged 10-14, and 16 reports of suicide among children aged 15-19.xlv
- 10 children under age 19 were killed by a firearm in South Dakota in 2020.xlvi

Child Welfare Services Funding

- South Dakota spent \$68,367,469 on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families.
- \$32,057,028 were allocated from the federal government and \$35,237,243 came from state and local funds.xlvii

- \$5,711,926 as part of the Title IV-E Foster Care Program.
- \$4,896,970 as part of the Title IV-E Adoption Assistance Program xlix
- South Dakota's sum of expenditures for Social Service Block Grants in 2020 was \$6,401,018
