

# Wisconsin's Children 2022

## Child Maltreatment

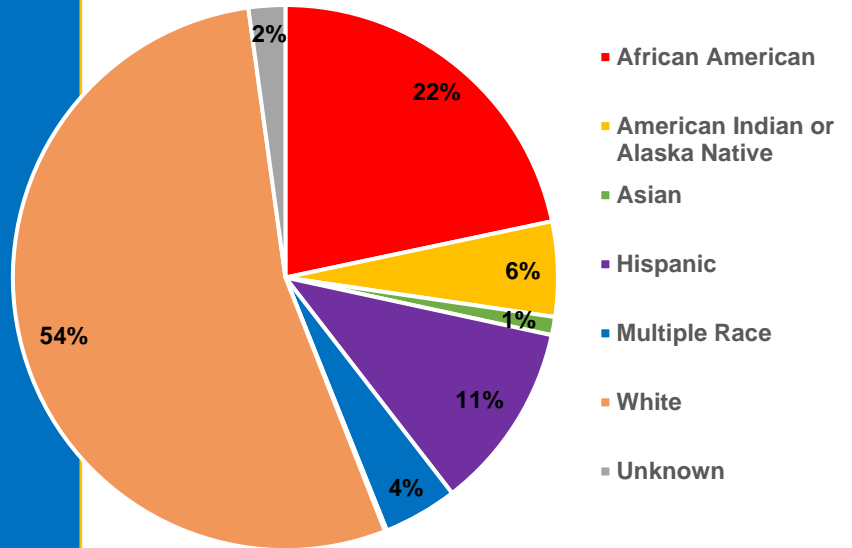
In 2020, Wisconsin had **72,064** total referrals for child abuse and neglect. Of those, **24,159** were referred for investigation.<sup>i</sup>

There were **4,177** child victims of abuse or neglect in Wisconsin in 2020, at a rate of **3.3** children per 1,000. This translates to a **13.4%** decrease since 2016.<sup>ii</sup>

Of the **4,177** children, **3,519** were first time victims.<sup>iii</sup>

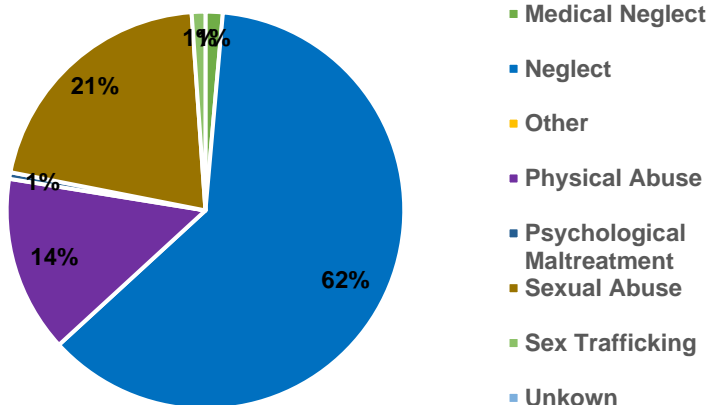
The largest age group of victims was children under one, representing **453** of the **4,177** cases.<sup>iv</sup>

## Types of Maltreatment Victims, 2020



- **61%** of child maltreatment perpetrators in 2020 were parents of the child. **39%** were non-parents or had an unknown relationship.<sup>vi</sup>

- **55%** of Wisconsin's child victims in 2020 were female while **45%** were male.<sup>vii</sup>

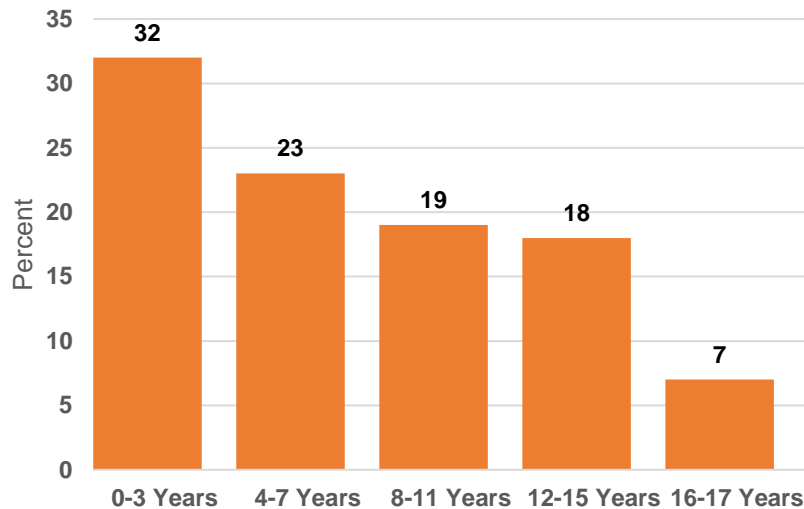
## Plans of Safe Care

- In 2020, Wisconsin reported **one** infant who was screened-in with prenatal substance abuse exposure.<sup>ix</sup>
- Wisconsin reported no plans of safe care for screened-in infants.<sup>x</sup>



# Wisconsin's Children 2022

## Age Distribution of Maltreatment Victims, 2020



• Child fatalities decreased in 2020 from **34** in 2019 to **32** in 2020.<sup>xi</sup>

• Wisconsin reported **50** total child victims of sex trafficking.<sup>xii</sup>

• **1,858** victims received post-response services while **2,561** non-victims received post-response services as well.<sup>xiii</sup>

## Foster Care and Adoptions

- **11,434** total children were served by the foster care system in FY 2020.
- **7,105** were in care on the day of September 30<sup>th</sup>, 2020.
- **4,001** children entered care during the 2020 FY while **4,329** exited during the same year.
- **748** of Wisconsin's children were adopted while **1,412** were waiting to be adopted.<sup>xv</sup>

There was a **7.2%** decrease in the number of children in care between 2019 and 2020. Adoptions from the system also increased **5%** from 2019 to 2020.<sup>xvi</sup>

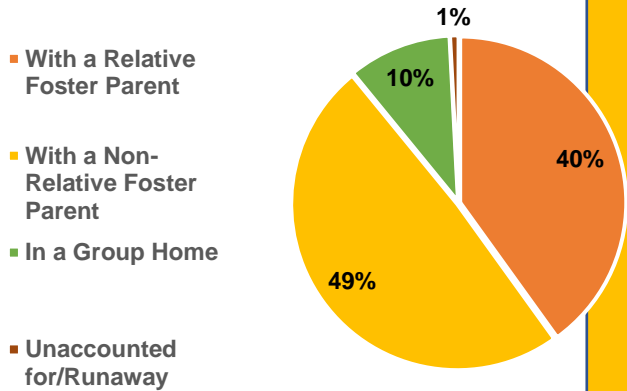
**387** children in Wisconsin aged out and exited foster care in 2020. This is an increase from **373** in 2019 and represents an **3.6%** decrease.<sup>xvii</sup>

- Children in foster care in 2020 spent an average of **20.2** months in care.<sup>xviii</sup>
- The average length of stay in Wisconsin for children waiting to be adopted from foster care is **39.8** months.<sup>xix</sup>
- The average age of children waiting to be adopted in 2020 was **7.0** years old.<sup>xx</sup>
- The average age of adopted children was **6.1** years old.<sup>xxi</sup>



# Wisconsin's Children 2022

## Where are Children in Foster Care Staying?



Data from 2019 shows that **3,586** children in foster care in Wisconsin were living with non-relatives while **2,931** stayed with a relative (See Pie Chart).<sup>xxii</sup>

**738** children were staying in group homes while **60** children were classified as runaways.<sup>xxiii</sup>

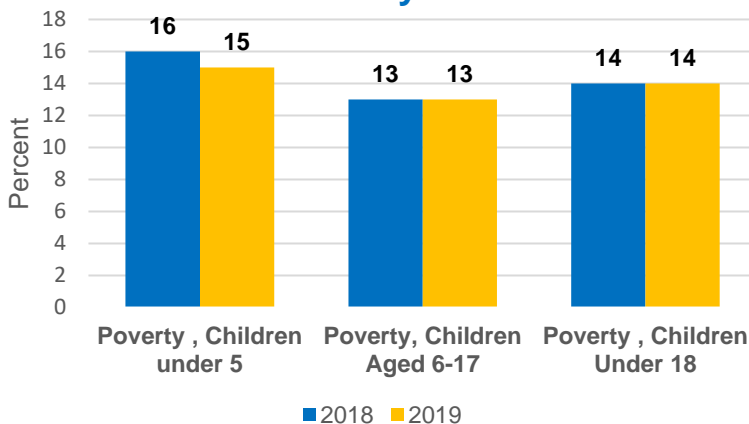
**2%** of households in Wisconsin in 2020 had a grandparent living with a grandchild.<sup>xxiv</sup>

The average length of time a child in care spent living with their current relative foster family was **11.1 months**.<sup>xxv</sup>

## Child Poverty

Wisconsin had **266,000** children in 2019 who lived with parents who lacked secure employment, representing **21%** of all children.<sup>xxvi</sup>

**22%** of Wisconsin's children lived in households with a high housing cost burden.<sup>xxviii</sup>

The average number of individuals receiving TANF grew from **29,621** in 2019 to **30,612** in 2020. This represents a **3.3%** increase.<sup>xxix xxx</sup>

The state spent **\$31,244,427** on WIC in 2021, serving **86,032** people. This represents a **1.4%** decrease in total participants and a **13.9%** decrease in spending.<sup>xxxi</sup>

**530,500** people in Wisconsin were food insecure in 2019, including **179,160 children** who struggled with hunger.<sup>xxxii</sup>

**37.2%** of households receiving SNAP benefits in Wisconsin in 2019 had children.<sup>xxxiii</sup>

## Health

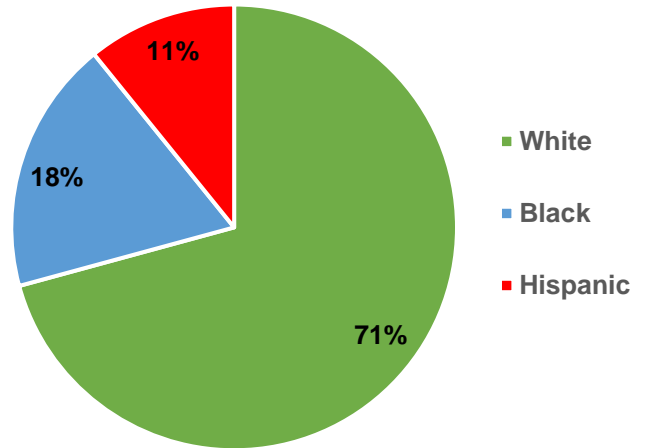
Wisconsin had **4,788** low birth-weight babies born in 2019 which is constituted as babies weighing less than 5.5 pounds. This translates to **7.6%** of infants born in Wisconsin in 2019.<sup>xxxiv</sup>

Wisconsin had a total of **6,366** preterm births in 2019, meaning completed less than 37 weeks of gestation. **9.3%** of all white babies were born premature while **15.8%** of black babies arrived prematurely in 2019. The total premature birth rate was **10.1%**.<sup>xxxv</sup>

There were **2,318** births to mothers aged 15-19 in Wisconsin in 2019, representing a rate of **13** in every 1,000 teen girls.<sup>xxxvi</sup>

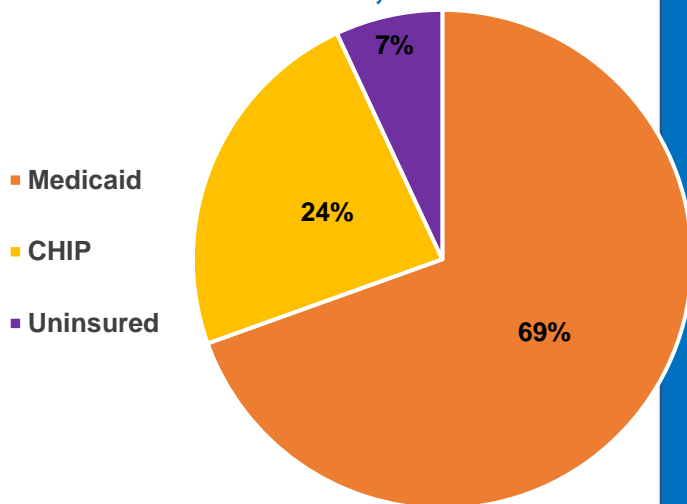
**371** infants under one died in Wisconsin in 2019, representing an infant mortality rate of **5.9** per 1,000.<sup>xxxvii</sup>

Public Health Insurance Coverage for Children, 2020



**3.8%** of Wisconsin's children had no health insurance in 2019. This represents **51,000** children.

**510,310** children in Wisconsin were enrolled in Medicaid in 2020. This represents **1.3%** increase from 2019.<sup>xxxix</sup>

**172,724** children in Wisconsin were in the state Child Health Insurance Program (CHIP) in 2020. This represents an **8.5%** decrease from 2019.<sup>xl</sup>

## Juvenile Justice System

- There were **33,383** total arrests for children under 18 in Wisconsin in 2019.
- **6,763** of these arrests were for Disorderly Conduct.
- **3,872** arrests were made for Property Crimes.
- **2,710** were arrested under the charge of Drug Abuse Violations.<sup>xi</sup>
- **477** children lived in juvenile correction facilities in Wisconsin in 2019. This is a decrease from **630** kids in 2017, representing a **24.3%** decline.<sup>xii</sup>

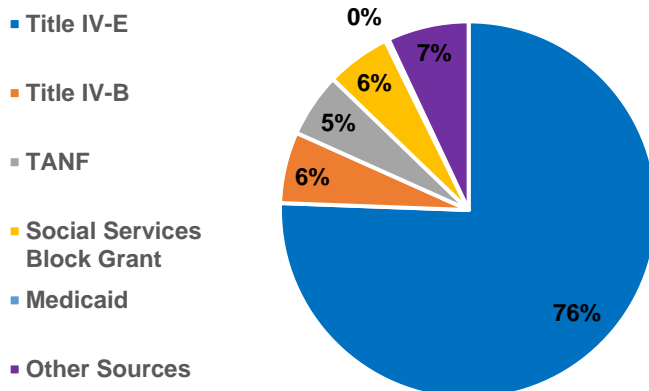
## Teens & Youth

- **16,000** (5%) of Wisconsin's youth were both not in school and not working in 2019.<sup>xiii</sup>
- In 2020, there were **11** reports of children in Wisconsin aged 10-14 committing suicide, and **33** reports of suicide among children aged 15-19.<sup>xiv</sup>
- **59** children under age 19 were killed by a firearm in Wisconsin in 2020.<sup>xv</sup>

## Child Welfare Services Funding

Wisconsin spent **\$499,074,263.86** on child welfare services in 2018. Child welfare services are all of the direct and administrative services that state agencies provide to children and families. **\$170,890,698.86** were allocated from the federal government and **\$321,469,370.00** came from state and local funds.<sup>xvi</sup>

The breakdown of the **\$170,890,698.86** in federal funding received in Wisconsin in 2018.<sup>xvii</sup>

- **\$8,918,975** as part of the Title IV-E Foster Care Program.
- **\$47,745,728** as part of the Title IV-E Adoption Assistance Program.<sup>xviii</sup>
- Wisconsin's sum of expenditures for Social Service Block Grants in 2020 was **\$43,011,478**.<sup>xlix</sup>
